The very basic for positive LifeQuality (LQ) is based on the Humane Needs and the supporting Human Rights. Realizing that 20 years ago, a formal proposal to ratify a 'Human Right Law' was delivered to the Government via a minister of parliament (MP). Quite honest, it came as a surprise when the NHRL 'Menneskerettsloven' passed in 1999. Legally, the most human democratic law ever, made the dawn of the millennium to come. However, - certain organizations disregards and fights the law fiercely, - knowing very well that some of their traditional practices have now become 'organized crime'.

Unfortunately, I have to be personal in the following to explain why and how such anti-LQ sub-cultures still dominates. I am simply a living proof of 20 years in exile-like conditions and prevented from professional work. For the time being, this is an attempt to describe how anti-LQ continues at personal, organizational, national and imperial levels. The UUs to come will therefore set such LQ focus with use of the 3x3 and 5D models and extended Game analyses.

The history and reason for all the civilized world-leaders to sign the Human Rights is described in UU 2013.juli.05. The concept of the NHRL (National Human Rights Law) is described in UU 2014.sept.05. In brief it is a Global 'One for All – All for One' agreement to prevent sociopathic mass-psychopaths to cause human disasters again, - and to secure anyone's basic LQ. The LQ concept is further developed from my 20 years old MSc Thesis 'IT&QL'. The NHRL, LQ, Human Needs and Rights are talked over in UU 2014.sept.05.

In summary: "Maslow's Hierarchy of Needs shows 5 main categories; Physical, Safety, Social, Respect and Self-realization." LifeQuality is defined as; "a person's totality of properties and potentials to satisfy stated and implied needs." "The 193 UN member-states are obligated to secure their citizens' rights concerning; private properties, self-determination, security, privacy, family, work, education, in addition to freedoms of thought, conscience, religion, expression and more." "All NHRL should at least include UNC (United Nations Charter) that provides the UN powers to investigate and mediate in international disputes and authorizes international economic, diplomatic, and military sanctions and force to resolve the disputes, - as well as the ICCPR (International Covenant on Civil and Political Rights) and ICESCR (International Covenant on Economic, Social and Cultural Rights). European nations should include the Charters of ECHR like the Norwegian NHRL has.

Unfortunately we were forced to leave Norway due to bureaucratic abuse shortly after the NHRL ratification. This paragraph simply lists the unjust we suffered by anti-HR subcultures abusing the public services. It is not meant as complains, but it is a firsthand testimony that such massive organized abuse and crimes are international and prevents civilized progress: Despite reasons, I lost my job in the LO dominated Televerket/Telenor even though the new MSc education was highly needed. European collaborating work became completely suppressed and hindered even though the EEA law clearly states that such is illegal. My business had to shut down and private properties were forced to sale due to repeatedly false taxations. It was annulled shortly after the shutdowns. Our family had soon to leave the country due to personal exhaustions. Our car was illegally confiscated by 100% illegal custom duty concealed as 'registration fee'. Labor unions arranged unfortunate situations and results and do blame opponents until they get fired. Unemployment benefits from the tax-payment were blocked by the unions due to secret minor fees and deals. Tax-authorities issued false penalty fees that causes serious financial crises. Pension savings were lost due to the financial crisis. Tax authorities forced detail investigation of private economy with references to criminal law, despite no legal reason. All in all, - our Danish/Norwegian core family would not have made it without spending some inherited money.

Some of the issues were formally complained to the ECHR. After 2 years on hold, it was annulled and maculated by some temporary clerk's claim of incorrect procedures. The whole process is well documented and was once published on the internet. Anyways, without doing any accounting, it must be safe to say that our losses in properties, prosperities, jobs etc. counts for millions. The issues mentioned does not count for the last 10 years. The main reason for staying low is the need to protect the minors from certain sub-cultures. It also seems that millions of families worldwide goes through similar abuses due to inefficient HR legalities. The losses in civil societies seem unmeasurable.

One might think that public organized crime can't be that bad or doesn't concern oneself or others. Trying to convince otherwise will take the rest of the year to talk through. However, it is really obvious and daily well documented that the world wars made organized crime one of the greatest public powers. Some evident examples are the fact the supreme laws "Menneskerettsloven" (NHRL), EEA Law (European Economic Area agreement) seems totally neglected in their 15 and 20 years of existence. Basically the laws forbid organized public crimes and are supported by the Constitutional Law (Grunnloven) and Criminal Law (Straffeloven). The results are hidden in plain sight. The economic crimes of scandalous public projects and services are mentioned in UU 2013.nov.01. UU 2013.sept.27 describes the basic professional knowledge about governing, maintain and innovating public services, - in addition to the massive critique in the 22/7 Commission's report. It says that "Leaders at all levels in the public sector (need to) systematic work to improve personal and organizational basic attitudes and culture concerning; risk acknowledgement, fulfillment, cooperation, IT-usage and result-oriented leadership." (See UU 2013.aug.09.) This is how harsh such a formal criticism can be and clearly indicates that the public sector is fundamentally malfunctioning. Even worse, it doesn't show serious signs of improvement since the 3 years has passed.

There are hypothesis that are hard to realize and acknowledge. There is clearly considerably organized crime within the legal system. The legal corruption makes the above mentioned issues possible and real. There is a simple explanation to this. Much of the traumatic wrongdoings in the previous century is not settled, reconciled and corrected, - in fact they are concealed, maintained and has built up a fierce immune system. It is simply well hidden in plain sight. However, today's information systems and internet provides the necessary information to correct the previous century's post-war propaganda with historical facts. The 5D model can be useful to realize the true history of our past.

Personal experience of today's Nordic bureaucracies stems from post-ww1 cultures. It is the very organizational Drive. The reason has now become clear with access to previously concealed information. Today, it is obvious that the infiltration, manipulation and assimilation of labor unions were seriously damaging personally, organizationally and nationally. This is talked through in UU 2013.aug.23, UU 2013.aug.30 and UU 2013.juli.05. In brief, the none-parliamentary labor union LO has dominated the governing Labor Party (AP) and public sector for a century. In 1923 AP submitted formally to the Moscow thesis in a concealed CdE Game. Formally, AP single-sided annulled the agreement, but that has never been confirmed by Moscow or LO. Even the declaration that AP became 'revisionist' instead of 'revolutionist' doesn't change the submission to the extremely violent empire. Still the final goal was to become a marionette government that promotes, infiltrates and manipulates, for a final annexation of the nation.

The cultures' realities might seem unbelievable from a civil democratic point of view. It contradicts all the sound morals, ethics and laws that any UN member should promote. However, that is the very foundation to such anti-HR cultures. It consider itself in war with weaker nations and permits any warlike means for the conquest. The concepts, arguments and activities were profoundly documented in the post '68 period with annexation of nations in Eastern Europe, Asia, Africa and South America. Some nations fulfilled the CdE, some didn't pass the massacre phases, some failed completely, but most nations worldwide merely suffered from the initial manipulations, destructions and deterioration caused by '5th colonists', pro-

Russian separatist and myriads of related so-called 'useful idiots'. The vast majority of undermining preparations wasn't followed up by Moscow at all, but simply became 'sunk cost' on the victims' side. However, it seems that activists still believe or is bound to continuous sociopathic activities at major civic costs. See UU 2014.juni.13.

Pro-Russian activists at that time were called communists of several kinds. They seemed to fight each other more fiercely than external opponents. What-ever the temporary label, - no doubt that most places of power was considered potential targets. The 3 constitutional powers, the Legal system, the Parliament and the Government/State/Communes were obvious in addition to centrals of mass communications. Except for the obvious NRK and Televerket, it included the institutions of education, like 'the folks' school' (folkeskolen) and the universities. Moscow supported the extreme propaganda that certain parties and narcissistic persons promoted. The unconditional support to masse-psychopathic patriarchs like Lenin, Stalin, Mao and Pol Pot did merely prove their anti-HR nature. That's the kind of personalities they forced into power.

However it failed on grown-ups in the universities so they targeted 'the path of the least resistance', - the 'bourgeois' (plebs') children in the 'folks school'. As mentioned, - with 12 years' experience from such cultures the systematic pedocratic abuses stem obviously from the post-68 generation's mass-psychopathic Drives. It includes skilled abuse of psychological pedocracy and psychiatric bureaucracy. Now they have become the oldest and most powerful generation in the system. The results have been very clear the past 12 year. Related issues to such sub-cultures in 'the folks school' (folkeskolen) are criticized on general basis in UU 2014.juli.11 and UU 2014.aug.01.

With today's information about the actors and events, it is obvious that such a massive anti-democratic, remotely controlled governing has been real for a century and still very much is. Even though the original declarations of 'armed civil wars' is lesser emphasized, such social-psychological hardcore Underworld Games are highly active today. Knowing that the real governor for AP/LO is Moscow, - a lot of policies, events and misdeeds can be clearer by use of 3x3, 5D and LQ Game Analysis.

The 'blinking dots' in the 4D political model is highly relevant to this. In brief the basic 3 dimensions of the model relates to the powers of Stat, Throne and Temple, as explained in UU 2014.sept.12. More concrete, the UU 2014.juni.27 says: "Political organizations changes over time. It can be shown in a 4D model, where the 3D powers show movements over time. Terms like conservative and radical is not fixed positions in 3D, but shows stillness and movement. Organizations can even be relative conservative or radical over time. LO is probably the Norwegian government's most conservative organization despite its extreme-radical origins. On the other hand, conservative organizations of the previous century can be relatively radical now, because they are not in position but opposition. The 4D model can also show organizations that comes and goes. Especially will the relation of short-lived extreme organization show to be pulsating constants in the 4D model, like the series of the pro-Russian separatist parties NKP, AKP, AKP-ML, RV and Rødt.» Note that extreme anti-powers will show up on the negative scale on the opponents' axis. In this case they will position themselves with values (-10, +10, -10) where the axis's are Throne, State, Temple. Furthermore, the majority is not as exposed as in registered political parties. Most are secret hardcore Underworld Game-player of CdE.

Anyways, the 3 Scandinavian LO factions are the most public organizations representing those sub-cultures. No doubt, I, as a dedicated promoter of NHRL and GHRL, have been considered an opponent for 30 years. All the related exile-like situations have also caused progress in understanding the culture and to find alternative explanations. It like Kremlinology and Vaticanology, - the complexity and oddities of the internal Games are beyond anyone's understanding, - even to themselves. Anyhow, the undisputed dominant 'Superior-Ego' to the LO cultures is Stalin. This 'Man of Steel', alias Ioseb Besarionis je Jūgāšvili, is the

archetype of Big Brother and makes top-score on most psychopath tests and indexes. He introduced mafia-methods to imperial-stat bureaucracy and caused definitively the worst crimes towards humanity world-wide. This is what LO insists submitting to, even though Russia itself rejected it in shame decades ago. Stalin is the very core of LO's social-psychological profile, culture and archetype.

The conservative obsession in LO to Stalin is evident in expressions, actions, silence and passivity. Their major gatherings still starts with obliged sing-along of 'The Internationale', the Stalinism's hymn, even though the Russians disbanded it as national hymn in shame of all Stalin's misdeeds. The rhetoric is still violently destructive like some spoiled childish bully, - or retarded brute. Actually, their criticism of innovation and the lack of own constructive tasks are remarkable. Simple T.A. shows that it is basically an underworld version of the 'Jante' Game. In this sense the 3x3 ego-state model for organizations is highly relevant. No doubt that Jungian collective synchronizations of UnderConscience Drive is fundamental for the whole movement. On the other hand, there isn't really much Will to talk about in LO because it is remote controlled. However, the OverConscience Belief (OB) is highly manipulated which through the decades changes anyone's UnderConscience Belief (OB). Alarmingly, this is the symptoms of neurotic psychosis. Furthermore, the LO/AP symbiotic struggles highly indicates organizational schizophrenia. The traumas from the nazist-stalinist D&C/U&C Games in WW2 wasn't settled and couldn't be entirely suppressed. It seems to re-appear in new dramatic Games of unpredictable outcomes.

Ever wondered why Norway is so alienated to Europe, why the legal system is so remote and why most 'extreme Left' arguments can be read in the English 'Pravda' on internet? It shouldn't be too surprising that the main reason is that the AP/LO commitments to the Moscow Thesis still dominates their sub-cultures. How to end this after half a century of 'cold war'? I think most such hard-core politicians very well know that the final cut to the AP/LO bound happened three years ago. The CdE attempt and massacre on parts of the AP/LO youth on 22/7-2011 did certainly set a 5D change of path. There is no way back to what it ever was. The whole incident is commented at the day in UU 22.juli.2011, during the trial in UU 18.mai.2012 to UU 20.juli.2012 and after the judgment in UU 24.aug.2012. There were several attempts to explain the complex events during the trial, but the vast majority of issues stayed unresolved due to the secrets of the Games. However, the recent year's events elsewhere in Europa has uncovered a surprising, but likely, hypothesis. The main question still is: What organizations can and will see through such a massive operation, with unhindered executions, leaving too few trials and overruling a national legal systems? "Follow the money" - and follow the footprints. ABB appears like a 'pro-Russian separatist'-wannabe.

The lyrics and the video of 'Uprising' speaks for itself in this UU relation. It is not our own civilization to we should oppose and fight to get proper LQ. It is the remote controlled forces of destruction. The three childhood friends Matthew, Christopher and Dominic formed the band Muse in 1994. They have been quite famous and won an MTV Video Music Award in the category of Best Special Effects for this video "Uprising". In addition they have Mercury Prize nomination, third place finish in the NME Albums of the Year, five MTV Europe Music Awards, six Q Awards, eight NME Awards, two Brit Awards—winning "Best British Live Act" twice, an MTV Video Music Award, four Kerrang! Awards, an American Music Award and been nominated for five Grammy Awards, of which they won Best Rock Album for The Resistance. Muse have sold over 15 million albums.
