

Billy Joel - We Didn't Start the Fire

All the united nations have stated borders for anyone to see at the UN web-site. Just as undisputable is the UNC (United Nations Charter), based on the ethics 'one for all – all for one'. Nearly all 200 nations have signed this to allow peaceful measures to pressure and stop violators. No truthful united nation goes to war despite the UNC. However, if so, all other nations are obliged to use force as the last option to prevent war. This UU will talk through the 3 chapter 'War' to investigate the development in relation to Games and the 5D and 3x3 models.

Wikipedia sum up chapter 3 'War' of the documentary 'Putin, Russia and The West' like this: "In August 2008, the Russia–Georgia war broke out. This episode discusses the political implications of this conflict for Russia's relationship with the West." Following there are some elaborations to the content, - followed by some comments and analysis. There will be special focus on Game theories and cold war history.

- Georgia arrested SU spies and publicly humiliated them. Putin warned that US support will not be sufficient. Later, Putin obviously did not want to meet the young afro-am woman as US foreign minister. Finally he stated clearly to tell the president that "I will do what I need to do". Diplomacy was practically cut.
- Poland requested US rockets for defense, but SU said they were placed there for offence. Putin proposed a new rocket strategy and Bush trusted him, - yet there was no real agreement. On the other hand, US informed SU that Iran can reach SU with nukes in a short while. Some US diplomats made proposals without political support and achieved further Distrust.
- Putin warned Georgia again that actions can back-fire. Both US and SU warned that US and EU is too remote to help. Pro-Russian separatists (PRS) in two Georgian provinces rebelled in armed conflicts. Georgia bought more US weapons and applied for NATO membership. US supported, but Merkel from East Germany indicated no. Merkel proposed an 8 month MAP period (membership action plan) conditioned no armed conflicts with SU.
- SU armed PRS in Georgia with weapons and upgraded the province's railroads. Meanwhile, Medvedjev was democratically elected as new president and Putin was degraded to prime minister. However, there was a secret agreement that Medvedjev was some kind of trainee without full powers. Georgia wanted to sign an international no-force treaty. However, US/NATO demanded Georgia to sign a no-force agreement with SU and US promised to stand by. Then Russian troops invaded a province, PRS snipers fired and SU military convoys invaded. Georgia was unable to call a cease-fire even with their president's appeal. PRS and Russia fires increases and Georgia was forced to respond. Medvedjev then ordered an invasion of 'peacekeeping' troops.
- Putin ordered full military invasion and war to destroy the Georgian army. SU demanded that the democratic elected Georgian president had to go (which is a definite CdE move). US broke the secret negotiations and informed the UN GA. SU then broke US diplomacy trust. SU and France negotiated and convinced Georgia to let the 2 provinces go. US lost trust in Georgia. However, the 2 provinces 'independence' got about 1% support in UN and is practically not legal.

Unfortunately, it seems necessary to stress that there is no doubt about any united nations' borders, regions and sovereignty, - and there is no doubt that all other united nations are obligated to help any violated nation against an aggressor. As mentioned in UU 2014.sept.05: "To put it simple, the Human Rights is a global democratic 'One for All – All for One' declaration. The need for this was very well understood by most humans and nations after ww2, - due to all the inhuman doings and destructions of nations and civilizations. The UN fundamental inter-national obligations are stated in the UNC (United Nations Charter) where chapter VI provides the UN powers to investigate and mediate in international disputes. Chapter VII

authorize international economic, diplomatic, and military sanctions and force to resolve disputes. The UDHR (Universal Declaration of Human Rights) is the foundation of the later ICCPR (International Covenant on Civil and Political Rights) and ICESCR (International Covenant on Economic, Social and Cultural Rights).”

The borders and sovereignty of Georgia and Ukraine are crystal clear and can be looked up by anyone at the UN web-site. Today’s Russia, with the FSB puppet president, have annexed 2 Georgian provinces, the Ukrainian region Crimea and have initiated, supported and secretly executed warfare against several Ukrainian regions. Till now the casualties are: Ukraine; killed 1,152–2,085, wounded 4,079, missing 400, captured 1,942. SU2 militants; killed 1,044, captured 300–1,200. SU2 soldiers; killed 200–300, wounded 450, captured 10. In addition, an airliner full of civilians is shot down and official OSSE inspectors have been kidnapped to prevent civilized elections. Moreover, Russia ‘invaded’ with 250 trucks to East Ukraine on August 22th and called it humanitarian help. In the same way, the annexations of eastern European nations in the previous century are not legal or valid, but results of fatal war crimes, - even though the responsible managed to hinder an international trail.

These are clearly a preparation phases before well planned invasions of Ukraine regions. Wars do not seem to be declared anymore, but rather denied. It is just the same procedures as for Georgia and for lots of other European nations in the previous century. On the other hand, the truth is made rather clear when promoting Novorossiia («New Russia») to the ‘pro-Russian separatists’. Yet, it is as fuzzy as the previous definitions of Russia, Moscow and the Soviet Union. Historical maps show that there have never been any legal acknowledgement like today’s ambitions. For example, the Grand Duchy of Moscow was a relatively small area under Tsar Ivan at the time of the constitution of Roma3, 500 years ago. It did not include Ukraine/Russia, or the lands nearby the Black Sea or the Baltic Sea (Norden). Actually, Ukraine was the land originally called Russia by Roma2, - not Moscow/Roma3.

There are lots of theories of why today’s Russia constantly do aggressive invasions of the neighbors’ regions, - despite the massive protests and insignificant support from some ‘friends’. The re-creation of cold wars has made serious diplomatic, economic and civil situations since the election in 2012. For example, president Putin was requested to leave the G20 meeting very early due to all the improper doings. Why do this at so high cost and so low success rate? 3 official main reasons stand out: 1. They need for land connection to the illegally annexed Crimea and the Black Sea. 2. To strengthen the rebelling Ukraine provinces for future annexations. 3. To challenge Ukraine, EU and NATO (for nationalistic support). They are likely reasons, - actually, there might be need to control all the land areas around the Black Sea including Crimea, Greece, Cyprus, Syria and possibly Suez for unhindered access to the Pacific and China. However, - Game analysis, indicate complex ulterior blurry motives that lies under the surface. It is necessary to look into its 500 year history of geo-politics, regional rivalries and obligations to the title ‘Roma3’.

The Roma3 CdE Games are dependent on disloyal hard-core Game-players in the targeted nations. Such were uncovered as RAF (Red Army Faction) during the cold war. This is talked through in UU 2014.juni.13: “However, most destructive of all were the indicated 100 RAFs with urban Stalinist mafia-guerillas. The following vast damages cannot be measured or documented. They can however be made probable by general knowledge of the costs of sociopathic civil wars. These damages are probably far larger than all the human and material known damages during the ww2.” In related writings, there have been attempts to label these highly secret and ulterior urban “fifth column’ armies. Yet, ulterior organizations will not ever allow identification. Anyways, in order to do so, the hypothesis is that there have to be RAFs in most of the united nations since the Roma3 ambition was global ‘revolution’ and submission. In other words, there were 100-200 RAFs like RAF-rus, RAF-chn, RAF-deu, RAF-esp, RAF-ita. For Norway, there is now necessary to talk about the new Moscow aggressions. 22/7 (Π) proves that. The next 3 paragraphs will focus on some

historical relations and the likely hypothesis that each Nordic nation have RAF sub-cultures in LO (Landsorganisationen).

This issue has been addressed indirectly several times and is merged and focused in UU 2014.juni.27: "On the other hand, 'conservative' organizations from the previous century might be rather radical now, since they are in opposition to the government. The 4D model can also show that certain organizations comes and goes. The relation of short-lived extreme organizations might appear to be pulsating constants in the 3D model, like the series of NKP, AKP, AKP-ML, RV and Rødt. A more recent oddity revealed during the Danish EP (European Parliament) election. The most profiled DF (Danish Folksparty) candidate promoted strong anti-European arguments, rather similar to Putin's during the Ukrainian contra-revolution, the annexation of Crimea and Nashi (Наши)-talks. It might indicate that Moscow has found new political relation in Europe and that the past century's loyalties will not be honored in this century." A main reason is of cause that no Nordic CdE with Roma3 submission was executed as promised. All the RAF/PRS just made a lot of noise, decay and misery, - but did not fulfill their CdE obligations to Moscow. Now the PRO and PRS of the 68-generation feed on the system, expecting prioritized public services and pensions, - like some Stalinized spoiled bullies.

There are lots of new information on RAF agents with the so-called Mitrokhin archives. Still, as for the re-cloaking of the STASI archives, there is not much revealed except that there certainly is much more to reveal. However, it's obvious that Moscow/Roma3 heavily financed and supported CdE sub-Games in the previous century and expected payback by total submissions as satellite-states. Therefor a well-documented, but highly denied hypothesis, is the existence of Stalinazism. The origin of the AP/LO dominating power in Norway is talked through in UU 2014.juni.13 and UU 2013.aug.30: "Wikipedia documents that LO was Nazi for 4 years during the ww2 and was consequently the major promoter of the invasion in Norway. 'Youngstorget' became the center of power with the main police-office and the LO-building side-by-side. The main network for Nazi intelligence and activities was at most working places in the public sector. Books of history does unfortunately not tell the 'whole truth' about what this terror-regime that caused un-recoverable damages to society. Documents are still locked down and unavailable for the public."

"The executions of the Norwegian national-socialistic leaders has probably not terminated the neo-Nazi-cultures in LO. It rather legitimated progressions for the next generation 'the national-communists'. The Stalin-Hitler cooperation before ww2 is well documented with the Molotov-Ribbentrop Pact' (1939-1941). Less known is the cooperation after ww2, where the national-socialists could convert to national-communists, - probably with some bindings and pay-backs." "Originally in the 20's, the supporters of the Moscow thesis were expelled from the ruling Arbeiderpartiet (AP) and formed their own national communist party (NKP). Since then, they have searched influence via LO instead, and LO has always demanded direct powers on AP in government." As mentioned in UU 2014.juni.06 and UU 2013.aug.23, the whole story of the dominating political alliance AP/LO is not well known in Norway, Norden or rest of the world.

Globally, the main hypothesis for this century is that RAFs are now converting to PRS (Pro-Russian Separatists) organizations like KGB converted to FSB. As mentioned in the previous UU 2014.nov.14. "Glasnost (openness) and Perestroika (restructuring) was the final fall of STASI, the Ministry for State Security, in the annexed East Germany. STASI had over 91,000 employees, 15,000 military and 173,000 informants/spies – about 2.5% of the population. Anyhow the statistics, 2% infiltration is an indication and a 'thumb-rule' that probably goes for the Nordic countries too. The STASI faction gives an indication of how the original Oprichnina has developed the past 500 years. It also gives an indication on how Praetor/Oprichnina has developed and become after 2000 years."

A most reputed RAF agent is called 'Carlos the Jackal' alias Ramírez Sánchez. He is currently in jail for double life-time in France for killing 11 people, injuring 150 and murdering of 3 agents. Historically, in 1968, Carlos opted for the Patrice Lumumba University in Moscow that was reputed as a notorious hotbed for recruiting foreign communists to the Soviet Union. He was expelled from the university in 1970 by disciplinary reasons, though. Then he travelled to Beirut and Lebanon, where he volunteered for the PFLP (Popular Front for the Liberation of Palestine) in 1970 and tried to establish his own organization with Syrians, Lebanese, and Germans. Carlos was also connected to the STASI that provided him with an office and safe houses in East Berlin, a support staff of 75, a serviced car, and allowed him to carry a pistol in public. The STASI files also show links to the KGB (today's FSB). There is no public information if Carlos and Putin had relations when they both were with the KGB in East Germany. However, Carlos the Jackal was most certainly closely related to RAF-dnk.

RAF-dnk is talked through in UU 2014.juni.13 and UU 2013.juli.1: "RAF (Rote Armee Faction) became reputed as a sociopathic civil war cells in western nations. RAF was designed after the Stalin concept from his past as a Mafia boss in SU/Caucasus. The leader of the Danish RAF (Blekingegadebanden), Gotfred Appel converted from Stalinism to Maoism. Consequently the RAF-dnk is related to the Beijing regime, even though it was indirectly controlled from SU. The attempt to kidnap (millionaire's son) 'Jörn Rausing' was a cooperation with RAF-nor and RAF-swe. It is uncertain if the detection shows that the Danes were more people or simply more clumsy. Besides, the extent of Moscow and Beijing cells (RAF-rus and RAF-chn) is uncertain, but likely significant and timely fatale. For example, the RAF-dnk brothers Weimann were consultants and installed computer-systems for the Police and Ministry of Foreign Affairs. They got confidential access and were responsible for the maintenance that includes access to read, copy and manipulate data. At the same time, the youngest made the so-called 'Jew-register', supposedly for the related organization PFLP.

The historical SU terms like KGB, STASI and RAF need adaptations to the 21st century SU2, - just like KGB converted to FSB. However, RAF2 or neo-RAF, would probably not be adapted terms in the media, since today's terms seem more neutral, remote and individual. For example, a decade ago, such the agents and related mobs were called 'autonoms' to shield their real sponsors when exercising in demonstrations and football matches. Today's terms are 'Oligarchs' and 'pro-Russian separatist'. In this way, today's RAF2 consists of PRO and PRS (Pro-Russian Oligarchs and Separatists.) There are most probably many such sleeping cells, neo-RAFs, in all 'western' nations. (See UU 2014.juni.13.) However, the cold war global revolution failed, - of cause it did when Roma3 relied on the worst kind of sociopaths they could convert behind the rivals' lines. The main idea might have been to make temporary BDW (Bad/Destructive/Wrong) values in the prey nation to simplify a CdE, - during an arranged general strike. However, it is beyond nativity to believe that forcing mass-psychopaths like some Stalin wanna-be's into power could ever make any positive results. That is simply a sociopathic Game with no care for the damages induced on other nations, organizations and persons.

Neo-Oprichnina had their century and now it is gone. However, it is rather transparent that this reality is not quite realized for the hardest core of sociopathic 4th degree CdE Game players. Some sub-Games of CdE, like LYAHF, TLM and DAC&UAC show that there can be a third ulterior global Game player. (Other CdE related Games are BGGG, OBD, ISR, EDAB and RPPP.) Actually, global 4th degree Games includes massive numbers of Players and otherwise involved. It is obvious to see from the scenes from last G20 meeting. US, French, German and Canadians made clear expressions, - and there were 20 actors at national level there.

However, there are other events that appears too absurd in the public media. There must be some more ulterior Game players behind the scenes. Strange are events like the 2 Malaysian airplanes where PRS and Putin got the blame for the second one. The PRS aggressions in the area are too provocative for US, SU or

EU to be initiated by themselves. It makes one think about the 2 arch-enemies of Roma3 that apparently have not publically got involved yet.

One main rival of Roma3/Oprichnina was originally the Mongolian empire (UU 2013.juli.19). Maybe not quite related, but remember the Albanian invasion of Kosovo that was supported by a NATO fleet close to Cyprus? - where a building full of Chinese spies were bombed? They are often omnipresent - hiding in plain sight. Other reminders appear. 500 years ago, Tsar Ivan's main objective was to stop the Mongolian terror of invasion, violence and taxes. Somehow it stopped and a deal was done. However, it seems that Ivan with Oprichnina used the same Mongolian way of terror to annex western regions like Novgorod, Ukraine/Russia, Baltic States and caused the Nordic Union to collapse. Besides, there was a fatal Russo-Japanese war just prior to ww1 that simply was interrupted before finished. Mongolia was converted to Stalinism just before ww2. After ww2 there was a Maoist/invasion of China, which practically made China a mongolized Stalinist state. However, the Chinese and the Mongolians do not recognize Roma3 as their superiors. Now that Roma5 seems to outmatch Roma3, there are certainly very hard Games at play at empire level.

Another arch-rival of Roma3/Oprichnina is the Muslims empire that caused the fall of Roma2 and foundation of the Ottoman Empire instead. Much of this is talked through in UU 2014.april.25. One main objective for Roma2 was to control the Black Sea and the related land areas. Roma3 did not fully follow up on that. Especially the important Crimea was controlled by the Muslims even though the tsar bought some privileges for a period. Stalin, however, is reputed for his cruel massacres of Muslims and Mongolians at Crimea. Anyways, the SU managed to push the Muslims' wars back to the Middle East with the Afghanistan and Chechnya wars, even though US took over after 9/11. (See previous UU 2014.nov.14. And the UAE (United Arab Emirates) was talked through in UU 2013.aug.02 due to a Norwegian HR case.)

Anyways, in addition to the mysterious cascade of CdE called 'Arabian Spring' there is a very ulterior 4th degree CdE Game player at stage. However, less mysterious is the Syrian war with several Muslim groups with loads and loads of Russian weapons, traded by murky Olicrates via Cyprus. Nevertheless, the newest actor in Muslim self-genocides is the so-called IS, alias ISIL alias ISIS. It does not seem to be true religious at all, but rather another neo-RAF, - Jackal style. In fact, the L in ISIL mean Levant that includes Jordan, Israel, Palestine, Lebanon, Cyprus and south Turkey, - which indicates that Israel is a long term goal. IS might as well mean 'Iblis State'.

"We Didn't Start the Fire" is a song by Billy Joel. Its lyrics include brief, rapid-fire allusions to more than 100 headline events between 1949 and 1989. The concept is rather 'Bob Dyl-ish'. The song was a #1 hit in the US and Billy is one of the best-selling artists of all time. The music video chronicles a middle-class married couple and their goal of the American Dream. It is full of symbols of the unrestrained social times during the cold war. The singer acts as an unseen but omnipresent observer, - like some secret service agent. Then the question is: "If 'we' didn't start the fire - who did?' 'Who are those 'we' anyways?' Possibly 'we' are any 4th degree global Game-players of Roma1, 2, 3, 4, 5 - and several other nations and organizations.
