

Joe Jackson- Crime Don't Pay (3)

The Dane Executive power is known as the 'Public Sector'. It is committed to provide products and services to Dane citizen and society as the Parliament and its Government order. A main reason to serious mismanages is obvious, - public servants are rarely investigated and put to trial according to the national penalty law. Some coldwar public servants are 'untouchables' to the Legal system. There is a saying 'Crime Don't Pay', - that should apply for all. However, evidently, the International criminal organizations are the main opponents to Dane cooperation with EUROJUST, EUROPOL and CEPOL, - and the resistance amongst civil servants is relatively high prior to the upcoming opt-in referendum.

International criminal organizations are 'Game players' by nature and psychosocial definition, - i.e. they have hidden agendas, do ulterior 'moves' to get unrightfully benefits - often at other's costs. In brief, according to Eric Berne, the fundamental attitude of Underworld Game-players says it all; 'honesty is for suckers'. (Games are explained in UU 2014.sept.12.) 'Underworld Games' was mentioned in the previous UU 2015.okt.16. "The article 'Political corruption' mentions several types of corruption like; extortion, comradeship, scandalizing, electoral cheating, fraud, 'financial mess', bribery and mafia activities. Global corruptions concern mainly drug-trafficking, human smuggling and whitewashing of money. The annual global political corruption is estimated to be about 1 trillion \$/year, the global GWP is about 70 trillion \$/y and the Norwegian (and Dane) GNP is about 1 trillion Kr/y. This means that the Norwegian (and Dane) political corruption is about 2% of the state's budget, i.e. about 20 milliard kr/y." Furthermore, "A classification (of deceptions) counts 34 categories. Bad faith, Barefaced lie, Big lie, Bluffing, Bullshit, Butler lie, Contextual lie, Cover-up, Deflecting, Delusions, Dismissal, Economical with the truth, Exaggeration, Fabrication, Fib, Fraud, Half-truth, Haystack answer, Honest lie, Jocose lie, Lie-to-children, Lying by omission, Lying in trade, Minimization, Misleading and dissembling, Noble lie, Omission, Pathological lie, Perjury, Polite lie, Puffery, Speaking with forked tongue, Weasel word & White lie."

Although silenced, there are serious indications of relatively high criminal activities in the public sector, - in the parliamentary Executive power. One deceiving misinterpretation is the CPI factor that is used as 'proof' of a low level of corruption in the Nordic nations. However, CPI means 'Corruption Perceptions Index', which tells the realized level of corruption – not the actual level. A low CPI might as well mean that the corruption is high and the perception of it is low (UU 2014.okt.24). CPI statistics are used as political arguments to not increase investigation of corruption.

Mafia - is a general term to identify and recognize international organized crime. Mafias are the main opponents to Parliamentary 'Rule by Law'. Such stereotyping is necessary for Game analyzing, - and to move focus from all those scapegoats and suckers that are scarified as 'expendables'. This focus will be set on the so-called 'Red Mafia' that is well documented in this post-coldwar century. It is the most powerful and widespread culture, has targeted European nations for a 100 years and is still highly political. However, this focus is not to forget all the other relevant mafias like the Italian, Albanian, Armenian, American, African, Asian etc.

The BBC / History video about the Russian Mafia documents that the so-called 'Red Mafia' that controls 40% of Russian economy, is the fastest growing, the most dangerous and operates at nation state levels. (See the Extra UU.) It also shows 100 years foundations to ww1, the imperial CdE (Coup d' Etat) and the mass assimilations in the SU Empire. However, there is no reason to ignore its cultural existence from Tsar Ivan's regime and the foundation of Roma3 and Oprichnina 500 years ago (UU 2015.okt.09). Anyways, in brief, the hardcore mafia of this century stems from several generations of Russians that survived the

Russian revolution, ww1, Stalin's mass-terrors, ww2, Gulag concentration camps and colonialization programs, and the Russian contra revolutions of Perestroika and Glasnost. Now, in this century, the Red Mafia got an intuitive culture where 'Rule by Law', national border and democracy and not apply, - and where personal profit is their utmost value-system. There should be no doubt that EUROJUST, EUROPOL and CEPOL are considered main obstacles to the Red Mafia and are dealt with as such - in their own ways. Most alarming, - there are convincing examples that FSB and GRU uses the Red Mafia Factions as PROSA in Imperial ambitions. (See the UU Theme base on the BBC documentary 'Putin, Russia and The West' in UU 2014.nov.07, UU 2014.nov.28, UU 2014.nov.21 and UU 2014.nov.14.). Actually, Putin was raised by street-gangs of Leningrad before admitted as a KGB/FSB agent and the puppet president in 1999.

The relations in Dane and Nordic societies become far more transparent when knowing the 100 years rise of the Red Mafia and the accordingly corruption of LEJ (Legislative/Executorial/Judicial powers). The public sector has cold war legacies that are not applicable, and even illegal, to this century's Denmark and Europe. The conditions and potentials of the nations are well documented in the OECD report 'Government at a Glance' and the Produktivitetskommissionens rapport (UU 2015.juni.05 and UU 2015.juni.26). Furthermore, Denmark and Norway seem to have some of the same fatal malfunctions in Police and Military as concluded by the Norwegian '22/7 Commissions report'. As talked through in UU 2014.okt.17. "The economic crimes of scandalous public projects and services are mentioned in UU 2013.nov.01. UU 2013.sept.27 describes the basic professional knowledge about qualitative governing, maintain and innovating public services, - in addition to the massive critique in the 22/7 Commission's report. It says that "Leaders at all levels in the public sector (need to) systematic work to improve personal and organizational basic attitudes and culture concerning; risk acknowledgement, fulfillment, cooperation, IT-usage and result-oriented leadership." (See UU 2013.aug.09.) This is how harsh such a formal criticism can be and clearly indicates that the public sector is fundamentally malfunctioning. Even worse, it doesn't show serious signs of improvement since the 3 years has passed." In fact, a recent joint police and military anti-terror exercise 'Gemini' proved no improvements since the terror attacks in 22/7 towards the Government and concluded that all the participants would have died. This also proves that far greater forces than the national ones are at Play, - and that the corruption of the national police and military forces cannot reach acceptable qualities without international cooperation and support, - in this UU relation - the EUROJUST, EUROPOL and CEPOL.

Public servants of the Executive power are obliged to execute orders from its Parliament/Government. If not doing so, they are to be prosecuted in accordance to the Penalty law by the Legislative power, - just like 'bourgeois' civilians. This obviously applies to legalities of this century too. As mentioned in UU 2015.juli.10, "There is no doubt that Denmark has be legally obligated for over 20 years by the Treaty (TEU - Traktaten om Den Europæiske Union)." Numerus of public servants have become criminal actors due to anti-European political actors' misinformation within public sector. The dilemma is thoroughly talked through in UU 2014.okt.24 with similar focus on Norway's relation to EU. "In 1994 the law-making Parliament ratified the EEA law concerning the European internal market instead of becoming a full member of EU. The new rules of competition caused considerable legal and commercial changes, - especially for the 3 constitutional powers; the Parliament (Legislative), the public sector and the legal system (LEJ). Suddenly, both private and public (oligarchic) cartel practices became illegal. The adaptations to legal practices are comprehensive, - which such dominant actors naturally resist. Today, 20 years later, there are just minor practical adaptations to the law. The media rarely seems to mention such illegalities and leaves the impression is that the law is practically neglected." UU 2013.nov.01

Furthermore, and similar to Denmark: "The Constitutional Law, the Human Rights Law and the EEA Law are all superior in their areas and can be related to the Penalty Law. The article 30 and 34 of the EEA Law prohibits customs duties, discriminatory taxes and measures having equivalent effects. The rules of competition forbid undertakings' abuse of market dominance, abuse of competition and discriminating agreements (art. 53 and 54). Public undertakings are regulated as well as the none-public ones (art. 59).

Unfair competitive public state aid to undertakings are forbidden (art. 61) and social support shall not be paid directly to any undertakings, but directly to the citizen (art. 61a)." (UU 2013.okt.04.) This means that alternatives to public service providers of schools, transport, health etc. became legal 20 years ago. However, illegal public discriminations are still discriminating in the markets in favor of own undertakings, oligarchic cartels and certain unions. A well-functioning parliamentary system would prosecute and settle this a long time ago." Furthermore, "The present government should initiate professional investigations by Riksrevisjonen (Office of auditors) and related according to the EEA Law. It is suspicious that Økokrim (Office of economic crime) do not have a section dedicated economic crimes in the public sector as it does for the private sector. Presumably there are hundreds of public mal-practices that should be legally prosecuted." (UU 2013.nov.01.)" These laws to promote democratic markets and are definitely anti-oligarchic. Consequently, Russian oligarchs are main opponents to the European Internal Market, - even though not saying so openly.

Furthermore, the SMEs (small and medium sized enterprises) are 80% of the market in Norden. They are particularly important for democratic nations, very defenseless towards predatory oligarchic competition and has extraordinary legal protection and support in accordance to European Legislation. Furthermore, "The SMEs suffer from illegally 'abuse of market dominances'. Besides, the EEA law obligates public protection and support to SMEs because the regional local societies will extinct if their SMBs suffers. The past 20 years growth of cartels in the primary industry is the main reason for the decay in local agriculture, stores and other SMBs. Contrary to anti-European propaganda, the solution is to protect those by the EEA Law and not by SU inspired agricultural industrialization. The farmers do run their own SMBs." However, with legal use of LOA, the public sector's enormous market would not be closed for SMBs. That would save a lot of them and consequently the fundament for regional cultures, - in addition to higher qualities and lower prices for the public purchases."

Coldwar propaganda has created an illusion that the market consists of a public and a private market. How untrue. Dominating oligarch have no exclusive right to state aid and exclusions from the law, - like some mafia 'untouchables'. Unfortunately, national SMEs are nearly cleansed out of the national market due to state-aid corruption, protection from prosecution and hostile dominance in the democratic markets. Consequently, deliveries of product and service to the civil population and public services have too high costs and too low qualities, - as stated in the OECD reports.

Most of the abuse of public services pin-points to one single organization,- the Nordic federal trade union – LO (Lands Organisationen). It was established during the ww1 with clear intentions and missions according to the Comintern. The NRK documentary 'LO sitt store comeback' (UU 2013.aug.23) proves that LO still corrupts LEJ in most aspects. "LO gave Arbeiderpartiet (AP) 13 million kroner for mutual benefits. In return, AP assigned ministry post, several board memberships in state dominated enterprises, altered regulations for social benefits and privacy, and introduce a so-called 're-communalization' in the city Trondhjem. All these gifts are beneficial for LO and contradicts several laws. LO was indeed taken to the Court for corruption, but the case was dismissed due to arguments of 'inaccurate formulations'." Furthermore, The Dane LO was discussed during the previous parliamentary election in UU 2011.Okt.14. "LO is not what they claim to be. It is a large capitalistic multinational enterprise with unrestrained greed for power and profit. It utilizes thousands of low-waged personnel for unpaid work in others' companies and departments. The rewards are alternative favors that is unregistered and not taxed. The economic key numbers of Dane LO are clear; the enterprise equity is as high as 655.6 million kr, there are only 148 paid employees, the annual result is calculated to be -17.3 million kr so LO do not pay any tax to Denmark. Corrupted employees in companies are 'helped' into positions, - especially with high power and low responsibility. Disloyalty towards the employer and loyalty to LO is unconditional. During the coldwar, LO got their agents on most sides of the negotiation-tables in public sector. However, LO is founded on the Comintern and remote

controlled. Consequently, LO agents in the Executive Power (public sector) are to execute orders of the Comintern, - and rewarded or punished for the results in Red Mafia ways.

The 21 condition of Third International (Comintern) was made in 1919. As mentioned in the previous UU 2015.okt.16, this Moscow thesis have been fundamental for national communist parties (NKP/DKP and successor) and the Nordic Confederation of Trade Unions' (LO). The 21 Conditions of Admission to the Communist International were suggested by Vladimir Lenin and formally adopted by the Second Congress of the Comintern in 1920. In brief, it declare wars towards the nations of Europe and America, at democratic civilians (bourgeois), encourages no mercy to its enemies, demands legal and illegal actions to execute Coup d' Etat (CdE) and demands unconditional submission to Moscow. There is no indication that such trade unions (LO) or parties (EL/Rødt) have ever annulled the bondage and submissions to the Comintern of 1919. There is no reason to assume that the demanding conditions are not still in effect.

Some quotes from the Comintern are: "Condition 3 (C3): In almost every country in Europe and America the class struggle is entering the phase of civil war. Under such conditions, the communists can place no trust in bourgeois legality. They have the obligation of setting up a parallel organizational apparatus, which, at the decisive moment, can assist the party to do its duty to the revolution. In every country where a state of siege or emergency laws deprive the communists of the opportunity of carrying on all their work legally, it is absolutely necessary to combine legal and illegal activity." C6: "no 'democratic' reorganisation of the League of Nations will be able to prevent new imperialist wars." (I.e. predecessor to UN and EU) C9: "Every party that wishes to belong to the Communist International must systematically and persistently develop communist activities within the trades unions, workers' and works councils, the consumer co-operatives and other mass workers' organizations. Within these organizations, it is necessary to organize communist cells, which are to win the trades unions etc. for the cause of communism by incessant and persistent work." C14: "Every party that wishes to belong to the Communist International has the obligation to give unconditional support to every soviet republic in its struggle against the forces of counter-revolution. The communist parties must carry out clear propaganda to prevent the transport of war material to the enemies of the soviet republics. They must also carry out legal or illegal propaganda, etc., with every means at their disposal among troops sent to stifle workers' republics." C17. "... The Communist International has declared war on the whole bourgeois world and on all yellow social-democratic parties. The difference between the communist parties and the old official 'social-democratic' or 'socialist' parties that have betrayed the banner of the working class must be clear to every simple toiler." In brief, - this International is simply a statement for 'International Crimes' that EUROJUST, EUROPOL and CEPOL fights.

There is no way that a small democratic nation can deal with imperial mafias. As mentioned in UU 2011.aug.26 and UU 2011.juli.29 in relation to the 22/7 assaults in Norway. "This was coordinated terror attacks, not merely towards the Norwegian Government, but towards all of NATO, EFTA/EU and the UN. Therefore, NATO shall be involved in the investigation. Furthermore, the police cooperation of Schengen (+ EUROJUST, EUROPOL and CEPOL) are most relevant. Norway (and other Nordic countries) have great need for considerable assistance from NATO and EU, because it is now obvious that we cannot handle it ourselves when divided. Particularly alarming is LO political psychotic symbiosis with the governmental AP." It should be clear in this century that LO has been used as a remote-controlled para-LEJ, - and is about to be upgraded according to the Russian reorganizations in this century.

Dane crises in the Executive power shows different indications. Some were talked through as the Pirate Bay vs CSC cases in UU 2015.feb.20. "It is necessary to control public data systems in order to execute CdE crimes. Such has not been proven in Norway, though highly indicated in many ways, - e.g. the delays in modernizing terror laws, the major failed IT projects, the obvious corruptions in investments, the failing communications, investigations and action. However, massive and long-lasting cyber-crimes has been uncovered in the Danish police. This was mentioned in UU 2014.nov.28: "The massive cybercrimes against

the Police, Military, Tax-authorities Public health in CSC Denmark and IBM mainframes were executed by disloyal employees, remote computers in Pirate Bay and controlled from Asia. The delays in police investigation indicate massive organized crimes that also include employees in the Danish police force. Therefore, it is simply beyond any nativity to claim that this major operation was organized by two young sociopaths.” “Most alarming is the extensive use of the hackers’ favorite operating system - Linux. Anyhow, the ongoing trial in Denmark is most probably just the tip of an iceberg in all of the public sectors in all NATO nations.” Furthermore as mentioned in UU 2014.dec.12 “Most alarming is the recent take-over of all IBM Intel Server in all NATO nations public and private sectors. (See UU 2014.nov.28.) Big Blue made Big Red by handing over the needed resources, network, servers and technology to execute considerable IT hacking, espionage, and info/money manipulations.” NATO nations’ public sectors do not seem to realize that most of their main IT systems are now legally in Chinese control too.”

It seems to be useful and necessary to repeat a summary of Games in this UU LEJ Theme. “This summary of defined Games from UU 2015.aug.28 might be helpful. “Criminal Games are mainly of the category Underworld, but can include categories like Life Games, Marital Games, Party Games, Sexual Games, Consulting Room Games and even Good Games’. These are often mentioned in UU and summarized in UU 2015.mars.06. “Some classic Games are. YDYB (Why Don't You, Yes But), IFWY (If It Weren't For You), WAHM (Why does this Always Happen to Me?), SWYMD (See What You Made Me Do), UGMIT (You Got Me Into This), LHIT (Look How Hard I've Tried), ITHY (I'm Only Trying to Help You), LPAFJ (Let's Pull A Fast one on Joey), NIGYSOB (Now I've Got You, You Son of a Bitch), LYAHF (Let's You and Him Fight), RAPO ‘Psychiatry’ and ‘Courtroom’. A complete list of Berne’s classic Games is talked through in his book ‘Games People Play’ that is now free on the internet. “Some (self-defined) new Games are: DAC&UAC (Devide&Conquer & Unite&Conquer), ISR (It Started with the Retribution), ABD (Attack is the Best Defense), Jante/TUD (The Ugly Duckling), TLM (Two Little Maids), BGGG (Bad Guy, Good Guy), RPPP (Robbing Pete to Pay Paul), ODAB (One's Death – Another's Bread) and the Russian BOOFY (Beat your Own and Others will Fear You), in addition to the new in extra UU 2015.okt.09, PPP Parroting Pravda Propaganda. Psychosocial Games are in general described in UU 2014.sept.12.”

There was a note about the Drive dimension in the previous UU 2015.okt.16 that will be talked through in the last UU of this Theme. “Such Games as CiH are from the 3^3 (3x3x3 dimensional) socialpsychological model (UU 2014.sept.12), - a completely redefined categorization of Games. It includes Jungian worlds of humanity’s nature that is far from fully explored. However, in brief, the 3^3 Game categories were related to the basic socialpsychological ego-states Drive (previously ID/Child) as AnnimalFarm (AF), WildLife (WL) and RainForest (RF) (UU 2015.feb.27). However, - although the 3^3 Game categories are relevant for societies, the simpler Berne 3D Game categories are more relevant for LEJ Game analysis.” Nevertheless, Drive is very relevant for the Red Mafia. The Gulag colonialization programs has been a breeder for Red Mafia cultures and become a global S-I in every European and American nations and states (ref. the Comintern’s 21 conditions.)

More relevant for this UU’s Executive LEJ dimension is the next psychosocial ‘Will’ dimension. As initially explained in UU 2015.mars.06: “The merged 3x3 Game model does mostly apply to the social ego-state ‘Will’. Freud and Jung call it ‘Ego’, but Eric Bern called it ‘Adult’. This UU sets focus on three social Game categories of Will, namely KoC (King of the Castle), CdE (Coup d’ Etat) and GoT (Games of Temples). Such a large theme needs an archetype to grasp the idea, - a simple stereotype like Napoleon. The main reason to focus on Games is the simple truth that everyone lies and deceives. This reality is underestimated and have serious consequences, - as the Charlie incident in Paris showed.” However, the most relevant Game category is rather called GdE (Games d’ Etat) that includes CdE and all the pre- and post-games related.

In relation to this second psychoanalysis of Dane LEJ, the 3^3 Game categories should rather be related as: KoC – relates to the Parliament and Government and all the games in there. (UU 2015.okt.16) GdE – relates

to the public sector that has been talked through in this UU. GoT – relates to all the believes, especially Platonic beliefs in the State and related isms. (See ‘isms’ in UU 2013.nov.29.)

Joe Jackson – ‘Crime Don't Pay’ has been used twice before and specially with focus on LO in UU 2013.aug.23. The title is certainly sarcastic. The song starts with some instrumental dramatic mafia introduction, followed by a quick dialog between a robber and a robbed. One is left in wonder on how much is true is really in the saying. The second part of the song is merely instrumental, - but descriptive as well. An amateur has obviously found an organ and tries to harmonize with the band. The organist has apparently everything left to learn, but is learning, - well guided and supported by rhythms and tunes from the band. The pianist whirls around the organist and pulls him in more harmonic directions. It is a pity though, that the producer faded them out before they completed the masterpiece.
